

KENT COUNTY PARKS & RECREATION

County Park Regulations

Applicability

All parks and facilities are overseen by the Kent County Parks & Recreation Department ("Department"), including, but not limited to: Bayside Landing Park & Pool, Betterton Beach, Edesville Park, Francis Cann Demonstration Woodlot, Millington Park & Pool, Toal Park, Turners Creek Landing & Park and Worton Park.

Regulations

- 1. <u>Hours of Operation</u> The property is accessible for unlimited public use during daylight hours for the purpose of lawful recreation pursuits. No unauthorized person or vehicle may enter or remain in a park or portion thereof from sunset to sunrise or at any time prohibited by posted hours of operation unless participating in a county approved program or with permission from the Department.
- 2. <u>Closing of Parks</u> The Department may close any park or portion thereof when deemed necessary for public safety and health, for protection of the parks' grounds, for fire hazards, for construction and maintenance, for park operations, or for park environmental protection.
- 3. <u>Closed Parks/Trespassing</u> It is prohibited to enter upon or into any county-owned land or facility at anytime when the land or facility is closed to the general public unless specifically authorized by the County Commissioners.
- 4. <u>Alcoholic Beverages</u> Possession of alcoholic beverages in the County's parks is prohibited and is strictly prohibited in pool areas and areas where youth events/activities are taking place.
- 5. <u>Under the Influence</u> No person under the influence of alcoholic beverages or drugs will be permitted in any county park.
- 6. <u>Tobacco/Marijuana-Free Policy</u> A person may not use any form of tobacco/marijuana, as hereinafter defined, in a restroom, at a spectator area, concession area, or playground in any Kent County park or recreation facility. Furthermore, a person may not use any form of tobacco/marijuana, as hereinafter defined, while on Kent County property, within 100 yards of an organized activity at a Kent County park. "Tobacco" includes, but is not limited to, cigarettes, electronic cigarettes, cigars, pipes, snuff, spit tobacco, or any other form of tobacco usage.

 - *For large scale private rentals, alcohol sales may be permitted, upon approval and licensure by the County Commissioners. Alcohol sales generally require a county issued liquor license for event caterers.
- 7. <u>Use</u> Park property and recreation and park programs are open to use for all members of the public, regardless of race, sex, national origin, color, or creed. The Department reserves the right to designate spaces for specific uses and or intended purposes such as softball only, soccer only, etc.
- 8. <u>Picnic Pavilions/Shelters</u> Use of picnic pavilions or shelters are first-come first-served, unless reserved for exclusive use. Exclusive use rentals require a security deposit and rental fee arranged through the Department.
- 9. <u>Athletic Fields</u> Scheduled use of athletic fields for sports leagues or other organizations are arranged and scheduled in advance through the Department. When there is no scheduled league or organization use, athletic field use is on a first-come first served basis.

- 10. <u>Interference with County Recreational Activities</u> It is prohibited for any person to interfere with, disrupt, or disturb any recreational activity duly authorized by the Kent County Parks & Recreation Department, whether such interference, disruption or disturbance is caused by the action of the individual, inaction of the individual, or by words, gestures, or other means.
- 11. <u>Advertising</u> A person may not erect or post any sign, notice, or literature in a park or facility nor use any loud speaker or public address system without first obtaining permission from the Department.
- 12. <u>Camping</u> It is prohibited to camp on, tent on, sleep on, or inhabit any roadside of any county road or along any county roadside, within the right-of-way of the road, or in any county recreational park or in, on, or adjacent to any county landing or any other county-owned property unless specifically authorized by law or resolution of the County Commissioners.
- 13. <u>Weapons & Firearms</u> No person, other than a law enforcement officer or otherwise authorized officer, shall carry, possess, or discharge a firearm or weapon of any kind on park property.
- 14. <u>Fires</u> No person shall build or cause to be built or set any fire except within established barbecue grills. No person shall leave any fire, and all such fires shall be thoroughly extinguished prior to leaving the site.
- 15. <u>Disturbing the Peace</u> No one may disturb the peace at any of the county parks. Live bands, loud or offensive music, or any excessive noise which disturbs the peace is prohibited except by permission from the Department.
- 16. <u>Commercial Activities</u> Peddling, soliciting, or conducting of any service, business, trade or occupation, including the taking of photographs and motion pictures for commercial use, as well as, conducting private instruction or lessons is prohibited except when approved by the Department via a Special Park Use Permit approval process. A rental fee is required for fee-based participation. A large scale special park use fee is determined based on the nature and size of the activity. Depending on the nature and size of the event, a security deposit of \$150, up to a maximum of \$500, may be required.
- 17. <u>Aeronautical Activities</u> Powered model airplanes or rockets may not be flown over or launched from any park, except for unmanned aircrafts as defined in Section 14-301(a) of the Economic Development Article of the Annotated Code of Maryland, the operation of which shall be in accordance with State law. Helium balloons, hang gliders, parachutes, ultra-light planes, or any other person-operated aircraft shall not be launched from park property.
- 18. Relics, Treasures, and Metal Detectors Without a permit from the Maryland Historical Trust, Department of Housing and Community Development, and Department of Public Works, an individual may not dig in search of buried relics or treasures, or remove prehistoric or historic artifacts. Permits are only issued to archeologists and other qualified individuals who present a plan for scientific investigation to be carried out under provisions of the Maryland Archeological Historic Properties Act. An exception to the permit requirements of this regulation is for the use of a metal detector in the search for coins, jewelry, and other items on designated park and swimming beaches owned by the County. A metal detector may be used during normal park hours with the following exceptions: 7 am through dusk April 1 through Labor Day.
- 19. <u>Animals</u> Per Kent County Public Law (Section 64 Domestic Animals), all dogs shall be kept under restraint. Animal owners shall be responsible for the removal of any excrement deposited by the animal. Violations will result in fines not to exceed \$400.
- 20. Fishing Fishing is permitted only in compliance with State law and posted rules.

- 21. <u>Flora and Fauna</u> Unless authorized by law, a person may not catch, molest, or kill any wildlife or disturb any nest, burrow, or den of any animal, or fowl. A person may not injure, remove, or destroy any flora. Planting of vegetation and/or digging into the surface of park property are prohibited except by permission of the Department.
- 22. <u>Gambling</u> Gambling, gaming, wheels of fortune, or other games of chance are prohibited except by permission of the Department.
- 23. <u>Hunting</u> Hunting or trapping is prohibited on park property except for animal control purposes or except as permitted by the Department.
- 24. Golf The hitting of golf balls is prohibited on County park property.
- 25. <u>Littering</u> No person shall discard, deposit, dump, or allow to blow away refuse of any kind in or upon park property, except by placing such refuse in a container provided for such purpose. No household trash may be discarded in a county park.
- 26. <u>Trees</u> No person may cut, saw, or injure any live or dead trees or part thereof with any type of equipment, power or otherwise, on park property, or remove any live or dead trees from park property, except by permission of the Department.
- 27. Traffic and Parking No person shall operate any motorized vehicle on park property other than on a road or street to which public access has not been prohibited. No off-road vehicles such as all-terrain four-wheels, unlicensed motorcycle, snowmobile, or golf cart, etc. will be allowed on County Property. Violators will be prosecuted (L Buses, trucks and commercial vehicles with commercial marking or tools of trade, with the exception of taxi cabs and tool trucks on service calls to disabled vehicles), shall not be operated on park property unless permission has first been obtained from the Department. User is responsible to inform participants of parking regulations. As there is limited parking within parks, parking in designated parking areas only shall be permitted. Any non-county vehicle on fields and unmarked grass areas is strictly prohibited at all times. Coaches are expected to ask players and parents for assistance to transport equipment to fields. Leagues will be held responsible for coaches and parents who drive/park on fields or unmarked grass areas. Fines of \$25.00 per vehicle will be assessed as applicable. Fines may be higher if damage occurs as a result of vehicles on fields or unmarked grass areas. KCPR and DPW personnel visit parks often and this area of concern will be regularly monitored and strictly enforced.
- 28.. <u>Automobiles</u> A person may not wash, repair or perform other work on any personal automobile on park property except in the case of emergency. No overnight parking of automobiles, tractor trailers, mobile homes, etc. Violators will be towed at the owners' expense.
- 29. <u>Paths and Trails</u> Only pedestrians and non-motorized vehicles may use those paths and trails designated by the Department as footpaths, nature trails, or bicycle trails. Horses, horse drawn vehicles, and motor vehicles shall be prohibited except by permission from the Department.
- 30. <u>Violations</u> Violators who do not comply with regulations will be asked to leave the premises. Failure to leave the premises after so directed shall be considered criminal trespassing.
- 31. <u>Indemnity/Hold Harmless</u> Kent County Government, its elected officials and employees are absolved of all responsibility for injury or loss sustained by persons or property as a result of the user's negligence or that of any member in their group.

- 32. <u>Enforcement</u> Department of Parks & Recreation employees and Department of Public Works employees have full authority in and on county-owned parks, land, and recreation facilities, including parking areas, and are authorized to enforce regulations.
- 33. <u>Rules and Regulations Regarding</u> The Department reserves the right to adopt additional rules, regulations, hours of operation, limitation of uses, or other standards regarding the use of county-owned property.
