MILLINGTON POOL FACILITY ACCESS PASS PROGRAM, FEES, & GUIDELINES

To ensure Kent County Parks & Recreation (KCPR) staff are familiar with and can identify patrons who enter and utilize Millington Pool, all patrons ages 12 and older must have and present a County issued Facility Access Pass (FAP) with a photo of the pass holder to enter and utilize Millington Pool. Patrons under 12 years of age must be accompanied and supervised by a responsible Facility Access Pass holder age 16 or older for admittance.

All patrons age 12 and older will be issued a FAP that must be presented at each entry.

All Kent County, MD residents (and their guests) shall be FREE of charge. Note: FAP holders under the age of 16 are not allowed to supervise guests.

All patrons who do not reside in Kent County, MD who are 3 years of age and older shall be charged a \$5.00 fee.

Pass Issuance Requirements & Guidelines:

Onsite issuance/purchase of passes at Millington Pool begins Memorial Day Weekend. To obtain a FAP, at the time of issuance, all patrons (12 years of age and older) will be required to provide the following information:

- First & Last Name and Full Mailing Address
- Date of Birth
- Valid Phone Number
- Valid Email Address (16 years of age and older)
- Emergency Contact Person and Phone Number(s)
- Answers to general questions about existing medical conditions for which Kent County Parks and Recreation should be aware should a medical emergency occur while utilizing the facility.
- Acceptance of the County's Pool Rules and Code of Conduct (pass suspended or revoked for noncompliance or unacceptable conduct). For patrons under 12 years of age, acceptance is required of parent, guardian, or accompanying responsible FAP holder who is at least 16 years of age or older).

Fees and Purchasing Policies:

Millington Pool is a cashless facility and does not accept any form of payment that would be required to be held at the site. The FAP must be purchased in person. All fees are required to be made via a credit or debit card only if purchased at Millington Pool. To use another form of payment, the purchase must be made in person at the Kent County Community Center located at 11041 Worton Road, Worton, MD 21678 during normal business hours (M-F).

FAPs are valid for the current season only, Memorial Day through Labor Day and must be renewed each season (proof of identity-name, residency-address, and age required at time of each renewal). All paid FAP purchases for patrons who do not reside in Kent County, MD are final, and no refunds shall be issued.

Kent County Resident Guest Policy:

Guests of age eligible Kent County resident FAP holders (16 years or older) will be admitted free of charge. All guests of Kent County adult resident FAP holders must be accompanied and supervised by the resident FAP holder and must enter and exit with the Kent County FAP holder. Kent County resident FAP holders are responsible for ensuring all guests adhere to all established policies and procedures.

Fees:

- All Children 2 Years of Age & Under and Kent County, MD residents – FREE Admission
- Guests of Age Eligible Kent County Resident FAP holder – FREE Admission
- Out of County Resident Patrons 3 Years of Age and Older - \$5 Per Person – Payment Required Each Entry.

Note: Same day re-entry requires FAP presentation before exiting, otherwise an additional admission fee shall be required.

- Individual Season Pass - \$100.00 Per Person (Children 3-12 Years of Age Issued Pass with Photo)
- Family of 4 Season Pass - \$295 (Each Family Member Issued Pass with Photo); Additional Family Member(s) - \$40 Per Person. Note: All must reside in the same household (Proof Required) and must be purchased in the same transaction.
- Individual and Family of 4 Season Pool Passes are honored at the Community Center Pool and Millington Pool.

Kent County Age Eligible Residents:

Must provide at least one (1) Document which provides Proof of Identity, Age, and Residency. Following are examples of acceptable documents:

- Valid US Passport
- Driver's License
- Vehicle Registration or Insurance Card
- ID Card (issued by Federal, State, or Local Government agencies providing it contains a photograph with name, date of birth, and address)
- Utility Bill
- Residential Lease Contract/Agreement
- Letter from Kent County, MD Agency identifying all persons in the (same) household and the address

Kent County Age Eligible Residents that cannot provide proof of residency will be required to pay the \$5.00 Per Person admission fee.

Kent County Government reserves the right to amend the Millington Pool Facility Access Program, Fees, and Guidelines at any time deemed necessary.
